- 2. Receipt and disbursement are properly and correctly shows in the accounts.
- 3. The cash balance and vouchers in the custody of the Manager/ Authorized Person on the date of the audit are in agreement with accounts.
- 4. All Account Books, Vouchers and Other documents and records required by us were produced before us. Subject to our Attached Notes.
- 5. Records of the inventory and movable assets have duly been certified by President/Hon. Secretary. Records have been maintained properly. Subject to our Attached Notes.
- 6. All the necessary information required by us has been furnished to us by the President/Hon. Secretary, whenever called upon. Subject to our Attached Notes.
- 7. No property or funds of the Associations were applied for any objects or purposes other than the objects or purposes of the trust.
- 8. The amount outstanding for more than one year is nil.
- 9. No tenders were invited for repairs or construction as no repairs or construction involving expenditure exceeding Rs.5000/- was carried out during the year.
- 10. The Association has not invested its funds contrary to the provisions of Section-35 of the said Act.
- 11. The Association does not own any immovable property. Hence the question of alienation thereof contrary to the provisions of Section 36 of the Bombay Public Trust Act does not arise.
- 12. We further report that the accounts are maintained on cash basis. Except Interest Income.

Comments Forming Parts Of Audit Report:-

- 1. We have observed that the Cheque return charges has not been recovered from the respective Members. Further we observed that the payment has not received from the Members whose Cheque were returned.
- 2. That Minutes book is not properly maintained and recorded.
- 3. We have observed that the EGM dated 28/10/2015 has disapproved certain expenditure and decided to recover the said amount with the responsible person's, which is still not recovered as on date of Audit Report. Hence we have shown this amount under the head loans and advances in the name of Mr. Ronak Sheth as per his consent latter dated 27/10/2015.
- 4. As we have been informed that there was embezzlement of Rs. 78695/-, by exemployee Mr. Yagnesh. We have yet not received satisfactory explanations from Mr. Ronak R. Sheth.so this Amount is shown under the head Recover against fraud to be settled A/c in Balance Sheet.
- 5. Amount Received on Behalf Of Mr. Ronak Sheth from Mr. Rameshchnadra Sheth against this Fraud is still not ascertainable, hence shown in the Balance Sheet in The Account of Rameshchandra sheth (A/C of Ronak Sheth)
- 6. The cash balance on Handing over date not handed to new President, Secretary and Treasurer are shown in the name of past President, Secretary, and Treasurer-cash account in the Balance Sheet.
- 7. TDS not Deducted from various bills are debited with penalty to responsible person's Name in the Balance sheet and credited to TDS payable Account. Also instruction for payment give to the office bearers of the committee to be paid as early as possible.



- 8. One Old Bank Account wide A/c No T-69 with Ahmedabad District cooperative Bank main Branch was found and amount as on 01-04-2015 38551.10 and some in operative accounts in that account interest credited till 01-04-2015 credited to Prior Period Items in the Balance sheet.
