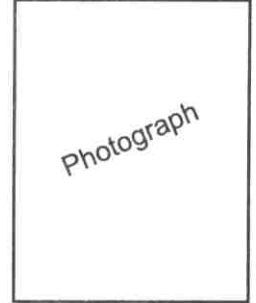

INSTRUCTIONS OF MEMBERSHIP

1. REGULAR MEMBER

Any Person entitled to practise under the I.T. Act, and / or practising under the said Act shall be eligible to become the member of the Association by furnishing proof of his / her practising e.g. degree of C.A., Advocate, LL.B., B.Com, with Accounting and Certificate u/s 288 of the Income Tax Act, 1961, etc.

2. NOMINAL MEMBER

The person who is not practising under I.T. Act, 1961 and has completed 50 years shall be taken as nominal member without having voting right and without admitting him / her under the benevolent Fund scheme.

3. BENEVOLENT FUND SCHEME MEMBERSHIP (Only for Regular Member)

Only person who can become regular member can be member of benevolent fund scheme. It is compulsory to become member under the Benevolent Fund Scheme for regular member.

Nominal Member cannot become member under Benevolent Fund Scheme.

4. For Regular Life Member, it is compulsory to become Life Member under the Benevolent Fund Scheme.

5. It will be the right of the Managing Committee to either accept the application or to reject it. Incase of rejection the fees paid will be refunded.
